# **Board Reports:**

### **Secretary Report.**

# **Chair Report: Bob Federico**

Prior to Chair updates Bob gave history of EVC, how to join and how to become a board member.

## **Possible Eastwood Incorporation:**

- Value/ primary objective:
  - Control area zoning and planning and development.
  - o Give voice and weight to neighborhood meetings.
- Concerns:

- o Expensive.
- Takes time. Need to start ASAP.
- Possible objection to increased tax, even though that tax would stay in our area.
- Beth Henderman shared guidelines for incorporation...number of residents needed and percentage to sign petition.
- Committee formed by meeting attendees. Need to:
  - Establish Eastwood boundaries.
  - Learn what other areas already doing and work with them.
  - Learn what neighborhoods are interested.
  - Check with League of Cities and see what they suggest.

## **Upcoming Mayoral candidate Eastwood Forum: Sept. 14.**

- Secure location.
- Send cover letter to candidates to see if available.
  - Not a debate.
  - To be given specific questions.
- Hope to have news coverage.

#### **Area Development:**

- Zoning change from R4 to R 5A for proposed apartments.
- Entrance would be located only 100 yards from failed intersection...most dangerous intersection in county.
- Community needs to attend next Wed. developer's meeting about this new development.

### Louisville Keep Your Fork update: Lucas Frazier

- Concern over continuing proposals to build in DRO.
  - o 2 new developments Echo Trial.
  - 20 developments along Floyds Fork.
- Ways to deal with situation:
  - Petition to get Floyds Fork protected.
  - o Get Metro Council to understand situation/problem.
  - Having a booth at State Fair.
  - Stay on top of resolution Metro Council passed to review the Floyds Fork Special District (FFDRO).

**Motion:** Sean Corser moved that Lucas Frazier be an At Large EVC Board member for the interim term of August to December 2022, and in December be nominated for the Board for a term of 2 years -- 2023 to 2024. John Darling seconded. Passed unanimously.

# Farmers Market: Ken Long

- Continue to have new vendors and continue to need booth help.

- Vendors want more market advertising.
- Asked about Board direction for the market.
  - This is Ken's last season to be in charge of the Market.
  - Sean will take on the bulk of the work.
